



# Lord's Gym Kids Mud Run 2026 Waiver of Liability and Release (Including Parent / Guardian Release for Minor Participants)

## Assumption of Risk

I understand that participating in the Lord's Gym Kids Mud Run — including but not limited to obstacle course racing, mud crawls, inflatables, bounce houses, foam pits, slip-n-slides, sledding, rock climbing, and family games — is inherently risky and may result in property damage, serious injury, illness, or even death.

I understand that certain activities may involve water, mud pits, ponds, foam, slippery surfaces, or submerged obstacles, and that participation may involve risks including drowning, near-drowning, hypothermia, waterborne illness, slips, falls, collisions, entrapment, and other serious hazards.

By signing this waiver, I voluntarily assume full responsibility for any injury, illness, death, loss, or damage arising from my and/or my child/ren's participation in any part of the Lord's Gym Kids Mud Run, whether caused by negligence or otherwise, to the fullest extent permitted by law.

## Health & Safety

I certify that:

- I and/or my child/ren are physically able to participate.
- We are not under the influence of alcohol, marijuana, illegal drugs, or any medication that would impair our ability to safely participate.

I knowingly and voluntarily accept all known and unknown risks associated with participation, including but not limited to:

- Falls, collisions, or injuries
- Drowning or water hazards
- Contact with other participants, volunteers, or unsafe terrain
- Equipment failure or obstacles in poor condition
- Exposure to extreme weather, illness, or disease (including COVID-19)
- Unseen hazards such as poison oak, sharp objects, wild animals, or insects

I agree that I am responsible for consulting with a physician if I or my child/ren have any recent illness, injury, trauma, medical condition, or disability that could affect safe participation.

## Liability Release

I release and hold harmless:

- Lord's Gym Oroville
- Lord's Gym Mud Run
- Father's House Restoration Ministries (FHRM)
- The Father's House Church of Oroville, Inc.
- Ridge View Event Rentals
- Father's House Acres

...together with all officers, directors, employees, volunteers, contractors, sponsors, vendors, agents, representatives, affiliates, successors, and assigns (collectively, the "Released Parties") from any and all claims, liabilities, demands, causes of action, damages, costs, or expenses of any kind (including attorneys' fees and litigation costs) arising out of or related to participation in the event, including but not limited to claims arising from bodily injury, illness, drowning, disability, death, property damage, or property loss. This includes any damage or loss in the parking lot and surrounding areas.

This release includes claims arising from the ordinary negligence of the Released Parties, including negligent rescue operations, negligent supervision, negligent maintenance of the premises, negligent instruction, negligent emergency response, or negligent operation of activities or equipment. The Released Parties make no warranties regarding the condition or safety of the course, obstacles, equipment, or premises.

I understand that this release does not apply to gross negligence, reckless conduct, or intentional misconduct to the extent prohibited by California law.

## Medical Consent

I consent to emergency medical care and transportation for myself and/or my child/ren if needed. I release the event and its affiliates from any liability related to such medical treatment or decisions made in an emergency.

**Media Release**

I understand and agree that any photos, videos, or recordings taken of me, my child/ren, or our property at the event may be used by the Lord’s Gym Oroville, FHRM, and their affiliates for any purpose, including marketing or promotions, with no expectation of compensation.

These images and recordings may be used, reproduced, published, distributed, or shared at their sole discretion.

**Event Cancellation**

I understand the event may be canceled or changed due to unsafe conditions (e.g., severe weather, natural disaster, labor dispute, pandemic, or other unforeseen events). If canceled, I will not receive a refund for any payments or donations.

**Behavior Expectations**

I agree that I and/or my child/ren will:

- Obey all event rules
- Treat others, property, and facilities with respect
- Follow instructions from staff and volunteers

The Lord’s Gym Oroville and FHRM reserve the right to remove any participant without refund for unsafe or inappropriate behavior.

**Parent/Guardian Responsibilities**

I understand that I am responsible for supervising my child/ren. I acknowledge that the Released Parties are not responsible for supervising participants outside of organized event activities or assigned volunteer roles.

**Environmental Hazards**

I understand that:

- Some obstacles may involve mud, water, or areas not tested for contaminants
- The course may include exposure to wild animals, snakes, insects, and hazardous plants
- Participation is at our own risk, regardless of these potential hazards
- Conditions may change throughout the event due to mud, water, weather, participant traffic, or other factors. I agree that I am responsible for inspecting obstacles and course conditions and choosing whether to participate in each activity.

**Severability & Governing Law**

If any portion of this waiver is found to be invalid or unenforceable under California law, the remaining portions shall continue in full force and effect.

This agreement shall be governed by the laws of the State of California. Any legal action related to this agreement or the event shall be brought exclusively in Butte County, California.

I understand that by signing this agreement, I may be waiving certain legal rights, including the right to sue and the right to a jury trial.
